- Implement, at Echo Glen Children's Center, the Juvenile Rehabilitation Administration's (JRA) mission, vision, values, goals, strategic plan, and the philosophy, functions, strategies and adherence measures of the Administration's Integrated Treatment Model (ITM). Implement the Institutional Component of the ITM/DBT
- Manage programs and services by implementing JRA and Echo Glen policies, procedures and practices; and achieving the goals and objectives.
- Serve as Clinical Director for the Institution: Provide leadership for the Clinical Direction and implementation of ITM throughout the campus. Hire and provide clinical supervision and training for psychology consultants and psychiatrists.
- Assure contract compliance for professional services provided by psychiatrists and psychologists. Provide written reviews. Provide direction and coordinate ITM consultants.
- Provide training (at the introductory, intermediate and advanced levels) on ITM and DBT for staff in living units, consultants, administrators, and new employees.
- Present and disseminate information on ITM and DBT to visiting clinicians, administrators and legislators.
- Monitor, schedule and provide suicide prevention and suicide treatment trainings.
- Attend and coordinate psychiatry meetings, Initial treatment Plan Reviews (ITPR), and Mental Health Advisory Team (MHAT) meetings. Plan and run executive clinical team meetings. Write and monitor executive clinical goals.
- Manage On-Call Employees: Recruit, select, hire, train and supervise on-call employees for the Campus.

- Determine risk for suicide as a Designated Mental Health Professional (DMHP); and establish precautionary procedures. Develop DMHP schedules. Provide quality assurance monitoring for Echo Glen DMHP function.
- Facilitate fifty percent of the weekly Clinical Forums.
- Promote a safe and secure environment for staff, residents and visitors. Implement and adhere to external standards including the Performance Based Standards (PBS), the National Commission on Correctional Health Care (NCCHC) standards, Department of Health standards and the Annual Loss Control Evaluation Standards (ALCE).
- Implement operational expectations. Manage human resources by implementing the Collective Bargaining Agreement (CBA), implementing personnel policies, recruiting, selecting and hiring qualified workforce, and promoting a positive work environment.
- Implement the ITM Quality Assurance: Assure compliance with the Case Manager Standards
- Manage Conditions of confinement: Ensure housing standards are well maintained
- Serve as one of six members of the Executive Team which includes the Superintendent, three Associate Superintendents, a Business Manager and a Human Resource Consultant: Serve as Acting Superintendent, when assigned. Serve as Superintendent's Designee consistent with JRA Policy Bulletins. Exercise authority over a Section in the absence of its Administrator. Serve as Treatment Coordinator for the PBS initiative
- Administer the Mental Health Cottage Section: Supervise/ the Program Managers for six 16 – 20 bed cottages (three residential mental health cottages)
- Fulfill Officer of the Day (O.D.) function on a rotational basis: Act on behalf of and with the authority of the Superintendent
- Participate in the development and administration of the \$14.5 million annual budget for the institution: Initiate authorizing signature for appropriate receipts and disbursement of Echo Glen funds. Exercise accountability for fiscally efficient staffing within assigned Section, including six living units, (i.e. the use of staff overtime, staff scheduling approval of cottage expenditures).
